## OFFICE MEMORANDUM

Subject:- Admissibility of Scheduled/Tribal Area Allowance to Central Government employees - regarding.

Reference is invited to Para '4' of Ministry of Finance, Department of Expenditure (DoE) O.M.No.17(1)/98-E.II(B) dated 17.07.1998 which stipulates that Tribal Area Allowance (TAA) shall cease to be admissible to Central Govt. employees in those States where it has been discontinued for the State Govt. employees w.e.f. the date(s) of such discontinuance and shall be admissible in those States where such allowance continues to be extended for the State Govt. employees and to OM No.17(1)/2008-E.II(B) dated 29.08.2008, whereby rates of TAA have been revised but all other terms & conditions for drawal of the allowance remain unchanged.

- 2. References are being received in this Department that the employees working in some Central Government Offices located at Ranchi viz. Income Tax Office, Central Excise and Service Tax office (Deptt. of Revenue), Central Bureau of Investigations (DoPT), Central Institute of Psychiatry (M/o Health & FW), Indian Institute of Natural Resins & Gums (M/o Agri.), etc. are enjoying the benefit of Tribal Area Allowance, which has been discontinued by the State Government of Jharkhand. In view of a draft Audit Para on irregular payment of TAA in Jharkhand, Financial Advisers of some Ministries have already been advised to take appropriate action in the matter.
- 3. Since TAA has already been discontinued by the State Government of Jharkhand, payment of Scheduled Area/Tribal Area Allowance to the Central Government employees posted in the State of Jharkhand is irregular. The Financial Advisers of all Ministries/Departments are advised to take appropriate action immediately and communicate the Action Taken, if required, to the Principal Director of Audit (Central), Indian Audit & Accounts Department, Lucknow, under intimation to this Department latest by 31<sup>st</sup> December, 2016 positively.
