

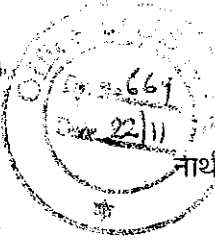

Keeping in view the above, I would request you to kindly advise the officers who are involved in budget work under your charge to maintain discretion while handling the budget matters and when interacting with the media personnel. It is also requested that only limited and essential number of Officers may be instructed to attend the pre-budget meetings in order to ensure confidentiality with regard to budget related data.
