ORDER

Subject: Deputation abroad of 5 officials from water and meteorology agencies of India to visit Australia during 20-24 November 2017 (excluding travel time).

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of following 5 officials from water and meteorology agencies of India to visit Australia for one week during the week i.e. 20-24 November 2017 (excluding travel time) to have detailed discussion on operational water forecasting and hydro-meteorological services, and water and climate data systems and services in Australia:

a) Sh. J. Chandrashekhar Iyer, Commissioner (FM), MoWR, RD & GR.

b) Sh. Ravi Shankar, Chief Engineer, P&D, Central Water Commission.

c) Shri Sanjay Kumar, Scientist - E, National Institute of Hydrology, Roorkee.

d) Sh. Deepak Kumar, SJC, NHP, MoWR, RD & GR.

- e) Dr. Ashis Kumar Mitra, Scientist G, NCMRWF (A representative from National Centre for Medium Range Weather Forecasting)
- 2. All the expenditure on the above visit i.e. international travel, accommodation, food and work related domestic travel in Australia for the above 5 nominated officers will be borne by Bureau of Meteorology, Australia. In view of this, each of the above mentioned officers is sanctioned daily allowance amounting to US \$ 150 (at the rate of US\$25 for 6 days) and the same may be booked under Head 2701.80.004.08.01.12 (FTE) under EAP and 2701.80.004.08.02.12 (FTE) under programme component of NHP for the year 2016-17.
- 3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.
- 5. The officials shall travel either on official or diplomatic passport and submit a report about the visit to Ministry of External Affairs (Southern Division) and Ministry of Water Resources, RD&GR (EA&IC Division) within one month of their return to India.
- 6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

7. This sanction issues with concurrence of IFD of the Ministry as conveyed *vide* their Diary No.250/IFD/2017 dated 17-11/2017.
