- 2. The above mentioned officials are sanctioned the following:

- (ii) **Hotel Accommodation**: To be arranged by Indian Mission in Myanmar
- (iii) **Daily Allowance**: US \$180 per head (@US \$60 per day for 3 days).
- (iv) Internal travel: As per actual.

All the expenses on the visit will be borne by Ministry of External Affairs. There will be no financial liability on the part of Ministry of Water Resources, River Development and Ganga Rejuvenation on the above visit.

The period of absence from the post in India and grant of pay and allowances and counting of increment for the official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 5.8.1976. The grant of CCA will be regulated in accordance with the provisions of that Ministry's O.M. No.2/3/E.II dated 27.11.1965 as amended from time

- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
- 5. The officials shall travel on official/ diplomatic passport and shall submit a tour report to Ministry of External Affairs (BM Division) and the Ministry of Water Resources (EA & IC Desk) within one month of his return to India.
- 6. Remuneration/ honorarium/ fees, if any, received by the officer during the visit will be governed by SR-11 and SR-12 (FR-SR Part-I) and GOI orders printed there-under.
