- 3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.
- 5. The official shall travel on official passport and submit a report about the visit to Ministry of External Affairs (Southern Division) and Ministry of Water Resources, RD&GR (EA&IC Divsion) within one month of their return to India.
- 6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
- 7. Officer shall ensure that the views expressed in this workshop/conference are his personnel are not that of Government of India and no secret or confidential data not in the public domain has not been used or would not be used.
