ORDER

Subject: Deputation abroad of Seven officers of MoWR/ CWC to the Netherlands during 15-26 May 2017 (excluding travel time) .

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of following seven officers to attend training on "Dam Safety and Reservoir Management (DSRM)" at Deltares in Delft, the Netherlands during 15-26 May 2017 (excluding travel time):

- i. Shri Sanjay Kundu, Joint Secretary(PP), MoWR, RD&GR
- ii. Shri Praveen Kumar, Director, Software Management Directorate, CWC
- iii. Sh. Bhopal Singh, Chief Engineer, Human Resource's Management, CWC
- iv. Sh. Nityanand Rai, Director, Hydrology (NE) Directorate, CWC
- v. Sh. Manoj Kumar, Deputy Director, DSR Directorate, CWC
- vi. Sh. Kayum Mohammad, Director (CMD), CWC
- vii. Sh. D S Chaskar, Director NWA, Pune

2. The above mentioned seven officers are sanctioned the following:

- (i) **Air Travel:** As per entitlement
- (ii) **Cost of Training (including registration fees, site visit etc.):** Euro 15092 (@Euro 2156 per head) – to be paid to Deltares
- (iii) **Hotel Accommodation:** Euro 19096 (@ Euro 2728 per head) – to be paid to Deltares*
- (iv) **Daily Allowance:** US \$1260 (@90% of US \$100 per day per head for 14 days)

* (Hotel Accommodation in Deltares would only be availed if cheaper hostel accommodation is not available and certificate to the effect would be obtained from Deltares, Netherlands.)

3. The above expenditure in respect of above 7 officers shall be charged to CWC's Major Head: 2701 M&MI, 80.General, 80.800.17, Dam Rehabilitation and Improvement Project, 17.01.12 FTE for the financial year 2017-18.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.



6. The official shall travel on official passports and submit a report about the visit to Ministry of External Affairs (Europe West Division) and Ministry of Water Resources, RD&GR within one month of their return to India.

7. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

8. This sanction issues with concurrence of IFD of the Ministry as conveyed *vide* their Diary No. 15/2017-FD dated 28.4.2017.
