**ORDER**

3. The officer shall travel on official passport.
4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
7. The officer shall submit a report about his visit to Ministry of External Affairs (Southern Division), Department of Personnel and Training and Ministry of Water Resources (EA & IC Division) within one month of his return to India.
