2. All the expenses on the above visit will be borne by the World Bank. There will be no liability on the part of Government of India on this visit.



5. The officials shall travel on official passports and submit a report about the visit to Ministry of External Affairs (WANA Division) and Ministry of Water Resources, RD&GR within one month of their return to India.

6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.


