**ORDER**

**Subject: Deputation abroad for Shri N.K. Mathur, Member (D&R), Central Water Commission to attend 19<sup>th</sup> PHEP-I and 11<sup>th</sup> PHEP-II meetings along with visits to project sites during 12-14 August 2017 (excluding travel time) in Bhutan.**

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of Shri N.K. Mathur, Member (D&R), Central Water Commission to attend 19th Punatsangchhu-I Hydro Electric Project (PHEP-I) and 11th Punatsangchhu-II Hydro Electric Project (PHEP-II) PHPA-II meetings along with visit to project sites during 12-14 August 2017 (excluding travel time) in Bhutan.

2. The above mentioned official is sanctioned the following:

- (i) **Air Travel:** As per entitlement
- (ii) **Hotel Accommodation:** Rs 16000 (@Rs 4000 per night for four nights).
- (iii) **Daily Allowance:** US \$240 (@US \$60 per day for 4 days). Officer may withdraw the DA either in India or in Indian Embassy in Bhutan.
- (iv) **Internal travel:** As per actual.

3. The above expenditure on this visit shall be charged under the CWC's Head 80.003-Trg. 01.00.12-FTE Non Scheme for the year 2017-18.

3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

5. The official shall travel on official/ diplomatic passports and submit a report about the visit to Ministry of External Affairs (SAARC Division) and



Ministry of Water Resources, RD&GR within one month of their return to India.

6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

7. This sanction issues with concurrence of IFD of the Ministry as conveyed *vide* their Diary No. 108/IFD/2017 dated 10.08.2017.
