ORDER

Subject: Deputation of Shri Sanjay Kundu, Joint Secretary, MoWR, RD&GR to Paris(France) on December 13-14, 2017(excluding travel time).

Sanction of the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation is hereby accorded to the deputation of **Shri Sanjay Kundu, Joint Secretary, MoWR, RD&GR to Paris** (France) to attend 1st Preliminary meeting of the 8th World Water Forum scheduled to be held in Paris (France) during 13-14 December 2017(excluding travel time).

2. Shri Sanjay Kundu, Joint Secretary (RD &PP) is sanctioned the following:-

- a. **Air Passage:** As per entitlement.
- b. **Daily Allowance:-** US\$ 300 for 3 days (@US\$ 100 per day). DA can be drawn either in India (MoWR) or from Embassy of India in Paris, France.
- c. **Conveyance:** Internal travel is to be arranged by Embassy of India in Paris, France. If the Mission is unable to make arrangements, hiring of car is allowed and the amount so incurred will be reimbursed on the production of actuals.
- d. **Hotel Accommodation:** As per entitlement, to be arranged by Embassy of India in Paris, France.
- e. **Airport tax/health insurance:** As per actual.

3. The officers shall travel on official/diplomatic passport. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

4. The entire expenditure on the visit of the officer mentioned above may be charged to Grant No. 98, Major Head No. 3451.00.090.16.01.12-Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2017-18.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the two officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-EIV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

7. A report about this visit may be submitted by the officers to Ministry of External Affairs (Europe West Division) and Ministry of Water Resources (EA&IC Division) within one month of his return to India.
