- (i) Air Passage (to and fro): As per entitlement.
- (ii) Daily Allowance: US \$ 405 (@ US\$ 75 per day for 6 days minus 10% of DA rate as breakfast is included in the accommodation) for each officer. Officers can draw the DA either in India or from Indian Mission in Israel.
- (iii) Conveyance (from Airport to Hotel and from Hotel to Airport): To be arranged by Indian Mission in Israel.
- (iv) Tuition Fees: \$US 63,000 (@\$US 3150 per person X 20 officials) to be paid to IDC Herzliya, Israel.
- (v) Hotel Accommodation: \$US 22,270 (for 9 rooms on double occupancy basis and 2 rooms on single occupancy basis for one lady officer and the head of the delegation) to be paid to IDC Herzliya, Israel
- (vi) Airport tax/health insurance: As per actual.

The above mentioned expenses on tuition fees shall be charged equally on OAE Head 2701.80.004.08.01.20 External Support and OAE head 2701.80.004.08.02.20 Domestic Support of NHP for the year 2017-18. Rest of the expenses shall be charged equally on FTE Head 2701.80.004.08.01.12 External Support and OAE head 2701.80.004.08.02.12 Domestic Support of NHP for the year 2017-18.
