ORDER

Subject: Training Course on Sediment Management in Reservoir and Run of River Hydropower Plants to be held in Bangkok from 4-6 October, 2017 (excluding travel time)

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of of Shri Kaushal Kumar, Assistant Director, Hydrology (NE), Central Water Commission for attending a training Course on Sediment Management in Reservoir and Run of River Hydropower Plants to be held in Bangkok, Thailand from 4-6 October, 2017 (excluding travel time).

2. The training course is being jointly organized by South Asia Water Initiative (SAWI) and the World Bank. The expenses on the above visit will be borne by the organizers and thus there will be no expenditure on the part of Govt. of India.
3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.
5. The official shall travel on official passport and shall submit a tour report to Ministry of External Affairs (Southern Division) and the Ministry of Water Resources (EA Division) within one month of his return to India..
6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
7. This sanction issues with concurrence of IFD of the Ministry as conveyed vide their Diary No. 191/IFD/2017 dated 29.09.2017.


