OFFICE MEMORANDUM

Subject: Domestic Preferences in Public Procurement.

The undersigned is directed to refer OM No. F.18/3/2017-PPD dated 06.04.2017 received from Public Procurement Division, Department of Expenditure, Ministry of Finance on the subject cited above (copy enclosed).

2. DoE, with reference to Rule 153 (iii) of GFRs 2017, has instructed ministries/departments to examine if there is any requirement of providing preference to the domestic bidders. An exercise pertaining to identification of goods (where there is sufficient domestic competition) for notification has to be carried out by this Ministry by 5th July, 2017.

3. Since views of MoWR, RD&GR are to be conveyed to Ministry of Finance within 90 days i.e. by 5th July, 2017 and may involve intensive discussions at MoWR, RD&GR level and decision on need for notification by MoWR, RD&GR under Rule 153(iii) of GFRs 2017, **desired information may be provided by 15th May, 2017 positively. Even where concerned wings have no information to furnish, they may certify the same and send 'NIL' information with reasons thereof.**
