**OFFICE MEMORANDUM**

**Subject: Continuation of ongoing schemes beyond  
12th Five year Plan - reg**

In the meeting taken by AS(Expenditure), DOE with FAs, it was advised that the Schemes should be independently evaluated by mid-May and sent to them for EFC and necessary approval by end of May. MOF would need at least three months to process the schemes of all Ministries.

2. MOF has also advised that the cost-benefit of third party evaluation may also be factored in and if in opinion of Ministry the requirement can be met through critical internal evaluation, in relation to smaller schemes, such approach may be adopted.

3. It is accordingly proposed that in relation to the following schemes, Committee(s) be set up within MOWR, RD&GR [with representation from NITI Aayog and other bodies like CSIR etc.] to conduct such evaluation within next one month or so and submission of report, particularly w.r.t. to continuation of scheme in its present shape/modifications and/or merger with other schemes based on progress and outcome during 12th Plan.

- a) **Implementation of National Water Mission** National Water Mission Directorate Preparation of State Specific Action Plans, Setting up of National Bureau of Water Use Efficiency, Baseline studies Preparation of Detailed Project Reports for demonstrative/benchmarking projects.
- b) **HRD/Capacity Building** Information, Education & Communication, National Water Academy Central Water Commission (NWA) Rajeev Gandhi National Ground Water Training & Research Institute Training

of MOWR Officers.

c) Research & Development

d) Infrastructure Development Ministry (Proper)- IT; Ministry (Proper)- e-governance ; CGWB (IT) CWC (L&B) Ministry (L&B); CGWB (L&B);

e) Irrigation Census

4. At this stage, this approach is being recommended only for such schemes where the cost of schemes for balance period of 14th FC is less than Rs.500 crore and SFC is to be carried out. Such Committees can be serviced by the respective SMDs and the concerned Wing Head/Divisional Head could be one of the members.

5. All the SMDs have already been advised to take suitable action and discuss the matter with JS&FA, if need be. In the matter of setting up of committees, such committees shall be constituted by SMDs after the approval of competent authority; the same shall be intimated to IFD accordingly.

6. This issues with the approval of JS&FA (MoWR, RD&GR).
