Subject: Deputation abroad of Shri Akhil Kumar, Joint Secretary, Ministry of Water Resources, River Decelopment and Ganga Rejuvenation to South Africa during 14-18 May'2018.

Sanction of the President of India is hereby accorded to the deputation of Shri Akhil Kumar, Joint Secretary, Ministry of Water Resources, River Decelopment and Ganga Rejuvenation to South Africa during 14-18 May'2018. (excluding journey time) to participate in the 4th meeting of BRICS Working Group in Pretoria from 14th to 16th May.2018) and BRICS Environment Ministers meeting at Durban, South Africa from 17th to 18th May 2018.

2. Shri Akhil kumar, Joint Secretatry, MoWR,RD&GR is sanctioned the following:

- (i) **Air Passage:** As per entitlement.
- (ii) **Daily Allowance:** US \$ 75 per day for 6 days = US \$ 450.
- (iii) **Conveyance:** Internal travel in South Africa to be arranged by Indian Mission at Pretoria and raise bills as per rules.
- (iv) **Hotel accommodation:** As per entitlements for 6 days (to be arranged by Indian Mission at Pretoria and raise bills as per rules).
- (v) **Airport tax:** As applicable in India and South Africa.
- (vi) **Mobile:** To be arranged by Indian Mission at Pretoria and raise bills as per Ministry of Finance Circular No. 24(1)/E.Coord./ 2010 dated 21-7-2010.


3. Shri Akhil kumar, Joint Secretary, MoWR,RD&GR shall travel on diplomatic/official passport.

4. The expenditure on the visit may be charged to Grant No.97, Major Head No.3451.00.090--16.01.12 – Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources for the year 2018-2019.

5. The period of absence from India and grant of pay and allowances and counting of services for increment of the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.76.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
