
**ORDER**

- The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.
- The officials shall travel on official passport and shall submit a tour report to Ministry of External Affairs (Northern Division) and the Ministry of Water Resources (EA&IC Division) within one month of his return to India.
- Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
- The visit may be undertaken only after obtaining vigilance clearance from MoWR, RD&GR in respect of above mentioned 4 officials.
