ORDER

Subject: Deputation abroad of Shri Rajiiv Ranjan Mishra, DG, NMCG and Dr. Pravin Kumar, Director (T-III), NMCG to attend 2nd Baikal International Ecological forum to be held from 20-21 September, 2018 (excluding travel time) in Irkutsk, Russia.

Sanction of the Competent Authority is hereby accorded to the deputation of Shri Rajiiv Ranjan Mishra, DG, NMCG and Dr. Pravin Kumar, Director (T-III), NMCG to attend 2nd Baikal International Ecological forum to be held from 20-21 September, 2018 (excluding travel time) in Irkutsk, Russia.

2. Each of the above officers mentioned above is sanctioned the following:-
 - i. **Air Passage:** As per entitlement.
 - ii. **Daily Allowance:** USD 400 (@US\$ 100 per day for 4 days including one night stay at Moscow due to unavailability of direct flight from New Delhi to Irkutsk, Russia). The officers can draw the DA either in India or from Indian Embassy in Russia.
 - iii. **Conveyance:** Internal travel is to be arranged by Indian Embassy in Russia. If the Mission is unable to make arrangements, car/taxi services may be availed for local trips (to be reimbursed on production of bills, wherever applicable).
 - iv. **Hotel Accommodation:** As per entitlement, to be arranged by Indian Embassy in Russia and raise the bills to PAO, MoWR, RD & GR, RD & GR.
 - v. **Airport tax/health insurance/ visa fees:** As per actual.
 - vi. **Mobile phone:** To be arranged by Indian High Commission and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
 - vii. The officer shall travel on official/diplomatic passport.
3. The entire expenditure of the above visit shall be charged on Grant No. 107, Major Head No. 3451.00.090.16.01.12- secretariat Economic services- secretariat- Ministry of Water Resources- Foreign Travel Expenses of the Ministry of Resources, RD&GR for the year 2018-19.
4. The period of absence from India and grant of pay and allowances and counting of services for increment of above officials will be regulated in accordance with the provisions of Para. 13-15 of Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer shall not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
6. The officer shall submit a report about the visit to Ministry of External Affairs and Ministry of Water Resources, RD&GR within one month of their return to India.
7. This issues with the approval of Screening Committee of Secretaries vide Ministry of Finance (Exp) DoE ID Note No. 300394612/E.Coord/2018-DC dated 13.09.2018 and with the concurrence of IFD of MoWR, RD&GR vide their Diary No. 257/2018-IFD dated 14.09.2018.
