ORDER

3. The entire expenditure on the visit of the officer mentioned above may be charged to Grant No.98, Major Head No.3451.00.090.16.01.12- Secretariat Economic Services-Secretariat-Ministry of Water Resources- FTE of the Ministry of Water Resources, RD&GR for the financial year 2017-18.


4. The period of absence shall be treated as official duty. The grant of pay and allowances and counting of increment for the above officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV(B) dated 05.08.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

6. Remuneration/Honorarium/Fees, if any, received by the official during visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

7. A report about the visit may be submitted to the Ministry of Water Resources, River Development and Ganga Rejuvenation (EA&IC Section) within one month of his return to India.
