

ORDER

Subject: Visit of Audit Team of MoWR, RD & GR to Nepal from 16.4.2018 to 27.4.2018 (excluding travel time).

2. The above mentioned officials are sanctioned the following:-
- i. **Air Passage:** As per entitlement.
 - ii. **Daily Allowance:** US\$ 60 per day for 13 days per head in respect of the officers mentioned at Sl. No. 2-5. US\$ 60 per day for 6 days in respect of the officer mentioned at Sl. No.1. DA can be drawn either in India (MoWR) or from Indian Mission in Nepal.
 - iii. **Conveyance:** Internal travel in Nepal to be arranged by Indian Embassy in Nepal, and raise bills as per the rules. If the Embassy is unable to make arrangements, hiring of car is allowed.
 - iv. **Hotel accommodation:** As per entitlements, for 13 days in respect of officers mentioned at Sl. No. 2-5, and for 6 days in respect of officer mentioned at Sl. No.1. It is to be arranged by Indian Embassy in Nepal and raise the bills as per rules.
 - v. **Airport tax/health insurance:** As per actual.
3. All the above officers shall travel on official/personal passport.
4. The expenditure on the visit may be charged to Grant No.98, Major Head No. 3451.00.090.16.01.12–Secretariat Economic Services -Secretariat -Ministry of Water Resources - Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2017-2018.



7. The Indian Embassy in Nepal is authorized to arrange hotel accommodation, as per tour programmes, internal transport and raise bills as per rules.


