- Registration Fees:** Euro 1,500.00 per delegate X 3 members = Euro 4,500 to be paid to ICOLD during registration.
- Air Passage:** As per entitlement.
- Daily Allowance:** - US\$ 400 for 4 days (@US\$ 100 per day for Secretary (WR, RD & GR) and US\$ 700 for 7 days (@US\$ 100 per day for other officers. DA can be drawn either in India (MoWR) or from Indian Embassy in Austria. (DA at reduced rates may be given if meals are provided/ included in hotel)
- Conveyance:** Internal travel is to be arranged by Indian Embassy in Austria. If the Indian Embassy/Mission does not provide official vehicle(s) during the visit, hiring of car is allowed for Secretary (WR,RD&GR) for local official trips. Rest of the officers may avail local taxi services for local official trips (reimbursable on production of receipt), wherever available
- Hotel Accommodation:** As per entitlement, to be arranged by Indian Embassy in Austria.
- Airport tax/health insurance/visa charges:** As per actual.
- Mobile phone:** To be arranged by Indian Mission and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.

3. The officers shall travel on diplomatic/official passports.

4. The expenditure on the visit may be charged to booked out of the DRIP under Head 2701 M& MI, 80.General.80.800.17,Dam Rehabilitation and Improvement Project, 17.02.12 FTE, for the financial year 2018-19.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.


