**NOTIFICATION**

**No.24/2019.F.No.A.32022/6/2018-Admn.** The President is pleased to appoint Smt. Varalakshmi Nagaraju as Principal Private Secretaries on 'ad-hoc' basis in Level-11 of the Pay Matrix (Rs. 67,700 - 2,08,700) in the Ministry of Jal Shakti, Dept. of Water Resources, River Development and Ganga Rejuvenation with effect from 04.06.2019 for the period up to 30.6.2019, or till the post are filled up on regular promotion, or until further orders, whichever is earlier:-

2. The above ad-hoc promotion is subject to following conditions:

- a. The ad-hoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointment or to claim seniority in the Grade of PPS of the CSSS;
- b. Ad-hoc appointments may be terminated at any point of time without giving any reason thereof;
- c. The services rendered on ad-hoc basis in the Principal Private Secretary grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade;
- d. The appointment on ad-hoc basis will take effect from the date of assuming the charge of the post of PPS in the Ministry/Department in which the officer has been Adjusted/posted.
- e. The appointment is subject to vigilance clearance in terms of DoPT's OM No.220341412012-Estt.(D) dated 02.11.2012 and other relevant instructions on the subject. The Ministry/ Department where the officer is working should promote him/her only after verifying that no disciplinary proceedings are pending or being contemplated against the officer;
- f. If any officer fails to avail ad-hoc promotion by 31.01.2019, the promotion order is liable to be cancelled.
