**Office Order No. 738/2019**

In terms of the provisions contained in sub-rule 10(i) of Rule 7 of Central Civil Services(Revised Pay) Rules, 2016 and the DoPT OM NO. 4/3/2017-Estt(Pay-I) dated 26.10.2018, the pay of Shri Manoj Khatter, PPS (PS of SL-2010), who was granted NFSG in Level-10 (in Grade Pay of 5400/- in Pay Band -3) w.e.f. 01.07.2014, is re-fixed with effect from 01.01.2019 after stepping up his pay at par with that of his junior, viz. **Ms. Prabha Gandhi**, PS of CSSS (SL 2014 and granted NFSG in Level -10 w.e.f. 01.07.2018), as detailed below:



2. Further, consequent upon his promotion to PPS of CSSS Cadre on ad-hoc basis vide Ministry of Water Resources, River Development & Ganga Rejuvenation's Notification No. 8/2019 (through F.No.A-32022/6/2018-Admn) dated 12-2-2019, the pay of **Shri Manoj Khatter**, PPS, is fixed in the Level-11 w.e.f 01-01-2019 (F.N) as per option exercised by the Officer (the date of next increment) as under:-

5.	Pay fixed as on 01-01-2019 in the grade of PPS in Level-11 in the corresponding cell equal to or higher than Rs. 82,400/-	83,300/- (in Level-11)
6.	Pay after grant of annual increment w.e.f. 01.07.2019	85,800/- Cell No.9 in Level-11)
7.	Date of next increment	01.07.2020

3. This order supersedes all the earlier pay-fixation orders issued in respect of **Shri Manoj Khatter**, PPS for the period mentioned above.

4. Arrears on account of above revision of pay, if any, shall be admissible to Shri Manoj Khatter, PPS. Further, the above fixation of pay and payments of arrears arising thereof, if any, is subject to audit observations. The overpayment made, if any, either in the form of arrears or otherwise, shall be recovered from the amount due to Shri Manoj Khatter, PPS subsequently.
