**ORDER**

2. All the expenses on this visit will be borne by M/s Kholongchhu Hydro Energy Limited (KHEL) and therefore, no expenditure will be borne by Government of India on this visit.
3. The officers shall travel on official passport. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
6. The officers shall submit a report about their visit to Ministry of External Affairs (Northern [Nepal, Bhutan] Division) and Ministry of Water Resources (EA & IC Division) within one month of their return to India.
7. This issues with the concurrence of IFD of MoWR, RD& GR *vide* their Diary No. 461/IFD-2018 dated 20.12.2018.


