ORDER

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

5. The official shall travel on official passports and submit a report about the visit to Ministry of External Affairs (Europe West Division) and Ministry of Water Resources, RD&GR within one month of their return to India.

6. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

7. This sanction issues with concurrence of IFD of the Ministry as conveyed vide their Diary No.127/IFD/2019-20 dated 31.05.2019.
