ORDER

Subject: Deputation abroad of Sh. Asok Kumar Gopala Pillai, ED (Projects), NMCG to London for attending Global Water Intelligence Conference during 09th to 11th April, 2019 (excluding travel time) – reg.

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of Sh. Asok Kumar Gopala Pillai, ED (Projects), NMCG to London for attending Global Water Intelligence Conference during 09th to 11th April, 2019 (excluding travel time).

2. Sh. Asok Kumar Gopala Pillai, ED (Projects), NMCG has been sanctioned the following:

- (i) **Air Passage:** As per entitlement (No booking shall be made in first class).
- (ii) **Daily Allowance:** US \$ 400 (@ US\$ 100 per day for 4 days). The DA will be provided by Indian High Commission in the London.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian High Commission in the London
- (iv) **Hotel Accommodation:** As per entitlement, to be arranged by Indian High Commission in the London
- (v) **Airport tax/health insurance/ visa fees:** As per actual.
- (vi) **Mobile phone:** To be arranged by Indian High Commission and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.

3. The entire expenses on the above visit shall be met from NGP head of National Mission for Clean Ganga and therefore, no supplementation/ expenditure will be borne by MoWR, RD & GR on this visit.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

6. The officials shall travel on official / personal passport and shall submit a tour report to Ministry of External Affairs (Europe West Division) and the Ministry of Water Resources (EA&IC Division) within one month of his return to India.
