2. Each of the above officers mentioned above is sanctioned the following:-

- i. **Registration Fees:** US \$ 1,695 per delegate + 13% HST, to be paid to ICOLD during registration.
- ii. **Air Passage:** As per entitlement.
- iii. **Daily Allowance:** - US\$ 400 (@US\$ 100 per day for 4 days ). DA can be drawn either in India (MoWR) or from Indian Embassy in Canada. (DA at reduced rates may be given if meals are provided/ included in hotel)
- iv. **Conveyance:** Internal travel is to be arranged by Indian Embassy in Canada. If the Indian Embassy/Mission does not provide official vehicle(s) during the visit, the officers may avail local taxi services for local official trips (reimbursable on production of receipt), wherever available
- v. **Hotel Accommodation:** As per entitlement, to be arranged by Indian Embassy in Canada.
- vi. **Airport tax/health insurance/visa charges:** As per actual.
- vii. **Mobile phone:** To be arranged by Indian Mission and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.

3. The officers shall travel on diplomatic/official passports.

4. The expenditure on the visit may be charged in proportion of 80% and 20% to Major Head: 2701 M&MI, 80. General, 80.800.17, Dam Rehabilitation and Improvement Project, 17.01.12 FTE and Major Head: 2701 M&MI, 80. General, 80.800.17, Dam Rehabilitation and Improvement Project, 17.02.12 FTE for the year 2019-20.
