Subject: Deputation abroad of 5 members' Indian delegation led by Mrs. T. Rajeswari, Additional Secretary (WR,RD&GR) to Dar es Salaam, Tanzania for attending first Joint Working Group Meeting from 15th - 17th May, 2019 (excluding travel time)- reg.

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of the following 5 members Indian delegation led by Mrs. T. Rajeswari, Additional Secretary (WR,RD&GR) to Dar es Salaam, Tanzania for attending first Joint Working Group Meeting from 15th -17th May, 2019 (excluding travel time):

2. Each of the above Officers has been sanctioned the following:

- (i) **Air Passage:** As per entitlement (No booking shall be made in first class).
- (ii) **Daily Allowance:** US \$240 (@ US\$ 60 per day per Officer for 4 number of days). The DA will be provided by Indian High Commission / Embassy in Dar Es Salaam,Tanzania.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian High Commission / Embassy in Dar Es Salaam,Tanzania. If the Indian Mission is unable to provide official vehicle during the visit, the delegation is allowed to hire taxi services for special official trips (to be reimbursed on production of bills wherever applicable)
- (iv) **Hotel Accommodation:** As per entitlement, to be arranged by Indian High Commission / Embassy in Dar Es Salaam,Tanzania
- (v) **Airport tax/health insurance/ visa fees:** As per actual.
- (vi) **Mobile phone:** To be arranged by Indian Mission/ Embassy and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.


The expenses on the above visit shall be charged upon Foreign Training Expenses Head of MoWR, RD&GR for the year 2019-20.

3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
