ORDER

Subject: Deputation abroad of Shri N. K. Mathur, Member(D&R), Central Water Commission to Bhutan for participating in Project Authority meeting and site visits during 31st January to 2nd February 2019 (excluding travel time) in connection with Punatsangchhu H.E Project.

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of Shri N. K. Mathur, Member(D&R), Central Water Commission to Bhutan for participating in Project Authority meeting and site visits during 31st January to 2nd February 2019 (excluding travel time) in connection with Punatsangchhu H.E Project.

2. The above officer is sanctioned the following:
 - i. **Airfare Passage:** As per entitlement
 - ii. **Daily Allowance:** \$240 (@\$60 per night for 4 days)
 - iii. **Accommodation:** To be arranged by Indian Mission/ Embassy in Bhutan
 - iv. **Internal Travel in India:** To be reimbursed on the production of actual.
 - v. **Internal Travel in Bhutan:** To be arranged by Indian Mission in Bhutan. In case, Indian Mission is unable to provide for accommodation, hiring of taxi will be allowed. The same will be reimbursed on the production of actual.
 - vi. **Mobile Expenses:** To be arranged by Indian Mission/ Embassy in Bhutan
3. The expenses on the above visit shall be charged to FTE head of Central Water Commission for the year 2018-19. No additional funds would be sought from MoWR, RD&GR on this account under FTE/Grants by the organization concerned.
4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.
6. The official shall travel on official/ diplomatic passports and submit a report about the visit to Ministry of External Affairs (SAARC Division) and Ministry of Water Resources, RD&GR within one month of their return to India.
7. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
8. This sanction issues with concurrence of IFD of the Ministry as conveyed *vide* their Diary No. 560/IFD/2018-19 dated 28.01.2019.
