

Sub : 5th Census of Minor Irrigation Schemes

The Centrally Sponsored Plan Scheme "Rationalisation of Minor Irrigation Statistics (RMIS)" was launched in 1987-88 with 100% Central assistance to the States/UTs. Since the XI Five year Plan RMIS scheme has become part of Central Sector Plan Scheme "Development of Water Resources Information System (DWRIS)". During XII Plan, RMIS was a sub-component of "Irrigation Census" component of the Plan Scheme DWRIS. Currently Irrigation Census is a standalone component under umbrella scheme-PMKSY and other schemes.

The main objective of the RMIS scheme is to build up a comprehensive and reliable database in Minor Irrigation (MI) sector for effective planning and policymaking. The major activity under the scheme is the Census of MI schemes conducted in the States/UTs covering all ground water and surface water schemes.

5th Census of MI schemes was conducted with reference year 2013-14 across the country in 33 States/UTs except Daman & Diu, Dadra & Nagar Haveli and Lakshadweep. Standing Finance Committee (SFC) in October, 2017 has approved the "Irrigation Census" scheme for implementation during 2017-18 to 2019-20 with a total allocation of Rs.257.78 crore. Against BE of Rs.29.55 crore (subsequently Revised to Rs.18.00 crore) only Rs.17.84 crore was incurred during 2017-18.

2. Reasons as to why the 5th census has not been conducted in Daman & Diu, Dadra & Nagar Haveli and Lakshadweep though the major activities under the schemes are the census of MI schemes conducted in the States/UTs covering all ground water and surface water schemes.
3. The actual date of commencement and completion of 5th census alongwith the schedule date of commencement and completion.
4. Whether there is any criteria in the census to depletion of ground water and restoration of surface water. If yes, details of the same. If not, reasons thereof.
5. Reasons for shortfall in various schemes in various regions in comparison to 4th census as detailed below :


