OFFICE ORDER NO.437/2020

In pursuance to DoPT's O.M. No. 4/8/2016-CS.I(D)(Pt.1) dated 27.8.2020 extending the benefit of split-option available under Saving Clause of FR-22(1)(a)(1) to ad-hoc CSS Officers who have been working on ad-hoc basis for more than a year without break and in supersession of pay fixation orders issued consequent upon her ad-hoc promotion to the grade of Under Secretary, the pay of Smt. Shalini Juneja, Under Secretary is fixed as under as per the option exercised by the officer :-

Pay as on 1.7.2015 after grant of Annual Increment of 3% in PB-3 of Rs. 15600-39100/- + Rs. 5400/- (GP) (notional)	Rs. 21400 + Rs. 5400/- = Rs. 26800/-
Pay fixed w.e.f. 1.7.2015 after grant of one increment of 3% in PB-3 of Rs. 15600-39100/- + Rs. 6600/- (GP)	Rs. 22,210 + Rs. 6600/- = Rs. 28,810/-
Revised pay as on 1.1.2016 in Level 11 due to fixation of pay on account of 7 th CPC	Rs. 76,200/-
Date of next increments and pay thereon in Level 11	<u>1.7.2016</u> Rs. 78,500/- <u>1.7.2017</u> Rs. 80,900/- <u>1.7.2018</u> Rs. 83,300/- <u>1.7.2019</u> Rs. 85,800/- <u>Rs. 1.7.2020</u> Rs. 88,400/-
Date of next increment	1.7.2021
