

2. The extension of ad-hoc appointment would be subject to following conditions:-
- The extended period of ad-hoc promotion would be from 01.07.2020 and upto 30.06.2021 or date of superannuation or date of their regular appointment in the grade or till further orders, whichever is earlier.
 - The ad-hoc appointment shall not confer on the appointees any right to continue in the grade indefinitely or for inclusion in the Select list of Section Officers for regular appointment or to claim seniority in the Section Officers' Grade of CSS.
 - Ad-hoc appointment would continue till regular candidates in Section Officer Grade are available either through Seniority Quota or Limited Departmental Competitive Examination (LDCE). In the event of the ad-hoc appointee not qualifying for regular appointment in either of these two categories, they shall be reverted to the ASO grade on availability of such regular officers from the date, the regular Section Officers join duty in their respective cadre units allotted to them by the Department.
 - The other terms and conditions would be as contained in DoP&T's OM No. 6/14/2015-CS.I(S) dated 01.07.2016, 03.10.2019, 08.01.2020, OM No. 6/4/2016-CS-I (S) dated 28.12.2018 and OM No. 6/1/2019-CS-I(S) dated 14.06.2019.
