The Government of India had recently reviewed the FDI policy for curbing opportunistic takeovers/acquisitions of Indian companies due to current COVID -19 pandemic.

In this regard Department of Promotion of Industry and Internal Trade (DPIIT) informed that an entity of the country, which shares land border with India or where the beneficiary owner of an investment into India is situated in or is a citizen of any such country, can invest only under Government route and the FDI proposals involving investments from these countries shall now be processed by the concerned Administrative Ministry/Department. DPIIT further requested for creation of a dedicated FDI Cell in the Department for processing FDI proposals.
