- iii. The SLP(C) No. 31288 arising out of the Hon'ble Delhi High court judgment dated 23.8.2017 in WP(C) No. 3490/2010 filed by The All India Equity Forum & Others Vrs UOI & Ors. And oher related court case in any competent court;
- iv. Any other connected cases in connected matter.
