Subject: Visit of 3 members Indian delegation led by Sh. Gajendra Singh Shekhawat, Hon'ble Minister for Jal Shakti to participate in the 9th World Water Forum (WWF) in Dakar, Senegal during 21-23 March, 2022 (excluding travel time) - reg.

Sanction of the President is hereby accorded to the deputation of the following three members Indian delegation led by Sh. Gajendra Singh Shekhawat, Hon'ble Minister of Jal Shakti to participate in the 9th World Water Forum (WWF) in Dakar, Senegal as per below schedule(excluding travel time which involves transit halt in Paris on 20.03.2022):

- All the above officers have been sanctioned the following: 2.
 - Air Passage: As per entitlement (Delhi-Paris, France-Dakar, Senegal-Delhi). i.
 - Daily allowance: US\$ 600 (@US\$ 60 per day per person). ii.
- Conveyance: Internal transportation in Senegal to be arranged by the Indian Embassy iii. in Dakar, Senegal and raise bills as per rules. If the Embassy is not able to provide official vehicle, hiring of 01 car is allowed for Hon'ble Minister and other members of the delegation are allowed to use taxi services for specific official trips (to be reimbursed on production of bills, wherever available).
- Hotel Accommodation: As per entitlements, to be arranged by the Indian Embassy in iv. Dakar, Senegal and raise bills as per rules.
- The arrangement during transit halt in Paris to be made by Embassy of India in France V. and raise bills as per rules
- Entertainment allowance: Rs.7,500/- for Hon'ble Minister for Jal Shakti if a vi. requirement is projected by the Indian Embassy in Dakar, Senegal.
- Gift Allowance: As per protocol norms for Hon'ble Minister for Jal Shakti. vii.
- Contingencies: As admissible for Hon'ble Minister for Jal Shakti being Head of the viii. delegation.
 - Airport Tax/Health Insurance/Visa Fees: As per actual. ix.
 - Airport Lounge: VIP Airport Lounge in Senegal to be arranged in respect of the delegation by the Indian Mission in Dakar, Senegal and raise bills as per rules.
 - Airport Lounge: VIP Airport Lounge in Paris, France to be arranged in respect of the xi. delegation by the Embassy of India in France and raise bills as per rules.
 - Mobile Phone: To be arranged by Indian Embassy in Dakar, Senegal and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
- xiii. Participation Fee: As per actual.

- 3. The expenditure on account of TA/DA in respect of the visit of Hon'ble Minister for Jal Shakti would be met from concerned Cabinet Secretariat's Foreign Visits Expenses Head for Council of Ministers. All other expenses in respect of the visit of the delegation may be charged from Major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper) Foreign Travel Expenses of the Department of Water Resources, RD&GR for the year 2021-22.
- 4. The Embassy of India in Dakar, Senegal shall provide necessary assistance/ logistic supports as required by Hon'ble Minister of Jal Shakti during his visit abroad. Hiring of car is allowed for the Minister and other members of the delegation are allowed to avail taxi services for specific official trips (to be reimbursed on production of bills wherever necessary). The Embassy of India in Dakar, Senegal is requested to arrange hotel accommodation, staff car and protocol arrangement for the above delegation as per entitlement. The Embassy of India in Dakar, Senegal is also requested to arrange daily allowances, entertainment, contingencies, mobile sim, gifts etc. as admissible to the delegation.
- 5. The above officers shall travel on Diplomatic/ Official passports. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
- 6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers shall not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction/approval of Government of India.
- 7. The other entitlement, if any, shall be in accordance with the Ministry of Finance, Department of Expenditure's O.M. No.19036/7/84-E.IV dated 21.08.1985 as amended from time to time.
- 8. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
- 9. The delegation shall submit a report about the visit to Ministry of External Affairs (Central & West Africa Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of return to India.
