2. All the expenditure (including Travel, Accommodation, TA/DA etc) on the above visit shall be borne by WAPCOS Ltd.



7. This issues with the concurrence of IFD of DoWR, RD& GR vide their Dairy No. 822/IFD/2022-23 dated 22.11.2022.


8. All the above officers must ensure to get the vigilance clearance from this Department before proceeding for the visit.
