2. The above officers have been sanctioned the following:
- i. **Registration Fee:** US\$ 4000 (@USD 800 per person) plus GST/Tax, if any.
  - ii. **Air Fare:** As per entitlement.
  - iii. **Daily Allowance:** US\$ 4000 (@\$100 per day per person for 8 days) to be provided by Indian Mission in Australia and raise bill as per rules.
  - iv. **Hotel Accommodation:** To be provided by Indian Mission in Australia and raise bill as per rules.
  - v. **Mobile:** To be arranged by Indian Mission/ Embassy in Australia and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2019.
  - vi. **Airport tax/health insurance/ visa fees:** As per actual, if any.
  - vii. **Internal Transport:** Transportation in Australia for the purpose of this visit, to be provided by Indian Mission in Australia and raise bills as per rules.
3. The above expenditure on the visit shall be charged on Head No. 2701.80.004.08.01 under FTE of NHP of Central Water Commission for the year 2022-23.
4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the

provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M No. 19036/7/75- E.IV (B) dated 5.8.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

6. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Order printed there under.

7. The officers shall submit a report about their visit to Ministry of External Affairs (Oceania Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of their return to India.
