

Minutes of the Review Meeting held under the Chairmanship of Joint Secretary(A, GW&IC)
on 07.06.2022 at 10:30 AM in his Chamber

The Meeting was held on 07.06.2022 at 10:30 AM under the Chairmanship of Joint Secretary(A, GW&IC) to review the land records on Government Land Information System (GLIS) portal uploaded by all the Organisations of DoWR RD & GR. In the review meeting following Division Heads were present on behalf of their respective Organisations :-

- (v) Shri Dheeraj Joshi, Deputy Secretary (NMCG)

The records of lands uploaded on GLIS Portal were reviewed by the Joint Secretary (A, IC&GW) and the following points were identified for further action:-

(1) It was observed that the unique Userid & Password has been provided only to 13 Organisations out of 23 and it has been decided to provide login credentials to the remaining 10 Organisations along with 5 tribunals of DoWR RD & GR in coordination with MEITY who manages GLIS portal for MoHUA.

(Action to be taken by: General Administration)

(2) Comprehensive data of the land details uploaded on GLIS Portal has to be shared with the Division Heads for their respective Organisations.

(Action to be taken by: General Administration)

(3) Login credentials of all the Organisations has to be shared with the Concerned Division heads and Division Heads of the respective Organisations would verify the data uploaded on the GLIS Portal in respect of their Organisations.

(Action to be taken by: General Administration & All Division Heads)

(4) Comprehensive data of the land details generated in the report of GLIS Portal is not in an organised manner which needs to be arranged Organisation wise in coordination with MEITY officials.

(Action to be taken by: General Administration)

(5) Contact details of the Officials of MEITY/MoHUA looking after the GLIS Portal needs to be shared with all the Division Heads/Organisation Heads in case of any assistance while uploading the land records on GLIS Portal.

(Action to be taken by: General Administration)

(6) No Organisation has reported surplus land on their part which needs to be verified by the concerned Division Heads.

(Action to be taken by: All Division Heads)

(7) The Organisations have only uploaded the details of their land however, no Organisation has uploaded the details of the buildings/construction details which is also needed to be uploaded on GLIS Portal in 'Add Building Section'.

(Action to be taken by: All Organisation Heads & Division Heads)

(8) It has been informed that MEITY is inserting a proforma in GLIS portal for submission of No Land Certificate. All Organisation Heads who have reported no land via email will submit the No Land Certificate on GLIS Portal (as and when implemented) for a comprehensive report on the part of DoWR RD & GR.

(Action to be taken by: All Organisation Heads)

(9) Organisation Heads or their Nodal Officers will also participate in the next review meetings or trainings if imparted in future.

(Action to be taken by: All Organisation Heads)

(10) All the above actions must be completed by 10th June 2022 (Friday).
