Posting: The officers will be posted in Department for Promotion of Industry and Internal Trade (DPIIT) or Ministry of Heavy Industries (MHI) based on vacancies and administrative exigency.

Job Description: Examination and giving technical advice on project proposals, licensing of various industries, Trade agreements, etc. and other administrative work in DPIIT and MHI.
