OFFICE MEMORANDUM

Subject: Utilisation of infrastructure under the National Industrial Corridor Programme (NICP) by National Industrial Corridor Development and Implementation Trust (NICDIT) for integrated development of industrial corridors in the country.

The National Industrial Corridor Programme (NICP) is an ambitious programme of the Government of India envisaged to develop new industrial cities as "Smart Cities" with sustainable infrastructure and the convergence of next-generation technologies in the infrastructure sector. National Industrial Corridor Development and Implementation Trust (NICDIT) is undertaken the integrated development of industrial corridors in the country.

2. Industrial Corridor Nodes/ Projects have been integrated with the network of multi-modal connectivity infrastructure in the PM GatiShakti, National Master Plan for providing seamless last mile connectivity for movement of people, goods and services.

3. Gol in Dec, 2020 approved the development of the following 11 Industrial Corridors comprising of 32 Projects as part of NICP which are being taken up in 04 phases.

- iv. Integrated Industrial Township, Vikram Udyogpuri, Madhya Pradesh

In consideration of the above, all the Ministries/Departments (as attached list) are requested to undertake widespread circulation of the above information to promote utilisation of the infrastructure created under Industrial Corridor projects and encourage industries to undertake setup/ expansion of industrial units in them.
