


2. The expenditure for the visit including travel, accommodation, visa etc., per diem will be borne by HTW Dresden, Germany.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of the Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and the Government of India's Orders printed there under.
6. The officer shall submit a report about their visit to Ministry of External Affairs (Europe West Division) and D/o of Water Resources, RD & GR (EA & IC Division) within one month of their return to India.
