3. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M No. 19036/7/75- E.IV (B) dated 5.8.1976.
4. The resignation or request for voluntary retirement from service while abroad shall not be entertained under any circumstances. The officer shall not stay abroad beyond the above-mentioned period under any circumstances without the prior sanction of Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Order printed there under.
6. The officers shall submit a report about their visit to Ministry of External Affairs (Central Europe Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of his return to India.
7. This issues with the concurrence of IFD of DoWR, RD & GR vide their Dy No. 303/IFD/2023-24 dated 13.07.2023


