

2. The above officers have been sanctioned the following:
- a) **Air Travel:** As per entitlement.
  - b) **Daily Allowance:** US\$ 600 each (@ \$100 per day for 6 days) to be arranged by India Mission in USA.
  - c) **Hotel Accommodation:** To be provided by Indian Mission in USA and raise bill as per rules.
  - d) **Telephone:** To be arranged by India Mission in USA and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
  - e) **Airport tax/health insurance/ Visa fees:** As per actual, if any.
  - f) **Internal Transport:** Transportation in USA for the purpose of this visit, to be provided by Indian Mission in USA and raise bills as per rules.
3. The above expenditure on the visit shall be charged on FTE head of the DRIP-II Scheme (Central Component i.e. CWC) for the FY 2023- 24.
4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 1903617175-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad shall not be entertained under any circumstances. The officer will not stay abroad beyond the above-mentioned period under any circumstances without the prior sanction of Government of India.
6. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
