- Mobile Phone: To be arranged by Indian Embassy in USA and raise bills as per MoF Circular X. No. 24(3)/E.Coord./2018 dated 26.03.2018.
- The expenditure on account of TA/DA in respect of the visit of Hon'ble Minister for Jal Shakti would be met from concerned Cabinet Secretariat's Foreign Visits Expenses Head for Council of Ministers. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
