2. The 10 officers of DoWR, RD & GR mentioned at S.No. 21 to 30 in the above table have been sanctioned the following:

- Air Travel:** As per entitlement.
- Daily Allowance:** US\$ 1400 each (@ \$100 per day for 14 days) to be arranged by Indian Mission in Canada.
- Mobile:** To be arranged by Indian Mission in Canada and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
- Airport Tax/Visa Fees:** As per actual.
- Registration Fee:** CAD \$ 189500 total (CAD \$18950 per person) to be borne by CWC under DRIP

3. The expenditure as mentioned at para 2 above shall be charged on the following Head of account:

- I.r.o officers mentioned at S.No. 21 and 30 of above table, expenditure shall be charged on major Head No. 2701.80.800.17.01.12(FTE-EAP)-50% and Head No. 2701.80.800.17.02.12(FTE-Domestic)-50% of CWC for the year 2023-24.
- I.r.o officers mentioned at S. No 1 to 20 of the above table, expenditure shall be borne by respective States/Agencies.


4. The Expenditure such as Air Travel, Daily Allowance, Mobile and Airport Tax/Visa Fees etc. in respect of officers mentioned at S.No. 1 to 20 of the table above shall be borne by their respective Ministry/State Govt./Organization.

5. All the other expenses including health insurance and transfers to and from the airport will be borne by respective State Govt./Agencies/Organizations.

9. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
10. The officers shall submit a report about their visit to Ministry of External Affairs (AMS Division) and Department of Water Resources (EA & IC Division) within one month of their return to India.


