Consequent upon grant of 1<sup>st</sup> Financial Upgradation under Modified Assured Career Progression Scheme vide this Department's Order No.647/2024(A-50/5/2021-Admn) dated 09.09.2024 & Corrigendum dated 13.09.2024 and in suppression of earlier orders of pay fixation, pay of Sh.
