Shanker Lal DS(Admin) to attend Korea International Water Week 2024 at the EXCO, EXCO Convention Center co-hosted by the Ministry of Environment, Daegu City, K-water, and Korea Environment Corporation from 13th to 16th November 2024 (excluding travel time).

Sanction of the Competent Authority is hereby accorded for the deputation of Sh. Raghav Langer Director (Atal Jal) and Sh. Shanker Lal DS(Admin) to attend Korea International Water Week 2024 at the EXCO, EXCO Convention Center co-hosted by the Ministry of Environment, Daegu City, K-water, and Korea Environment Corporation from 13th to 16th November 2024.

2 .The above officers have been sanctioned the following:

- a. Air Travel: As per entitlement.
- b. Daily Allowance: US\$ 1200 (@\$150 per day for 4 days) {\$600 each} to be arranged by the Indian Mission in the Republic of Korea.

- e. Airport tax/health insurance/ Visa fees: As per actual, if any.
 - f. Internal Transport: Transportation in the Republic of Korea for the purpose of this visit, to be provided by the Indian Mission in the Republic of Korea and raise the bills as per rules.
3. The above expenditure on the visit shall be charged on major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper), Foreign Travel Expenses of the Department of Water Resources. RD & GR for the year 2024-25.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of the Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-ii and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
6. The officers shall submit a report about their visit to the Ministry of External Affairs (East Asia Division) and Department of Water Resources (EA & IC Division) within one month of their return to India.
