- 3. The above expenditure on the visit shall be charged under head FTE (2701.80.004.08.01.12 (EAP Component) + 2701.80.004.08.02.12 (Program Component) under NHP], CWC for the year 2024-25.

- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of the Government of India.
