3 . The expenditure towards the above will be under Head:2701.80.004.08.01.12 (FTE) & 2701.80.004.08.01.09 (TE) under External Support and 2701.80.004.08.02.12(FTE) & 2701.80.004.08.02.09 (TE) under Domestic Component of IA (CGWB).

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

6. The officials shall travel on official passports and submit a report about the visit to the Ministry of External Affairs (Central Europe Division) and the Department of Water Resources, RD&GR within one month of their return to India.

7. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
