2. The Asian Disaster Preparedness Center (ADPC) will provide economy-class air tickets for the most economical route and a lump sum Daily Subsistence Allowance (DSA) for the duration of the workshop in line with ADPC's policy.

3. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M No. 19036/7/75- E.IV (B) dated 5.8.1976.

4. The resignation or request for voluntary retirement from service while abroad shall not be entertained under any circumstances. The officer shall not stay abroad beyond the above-mentioned period under any circumstances without the prior sanction of the Government of India.

5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Order printed there under.

6. The officers shall submit a report about their visit to the Ministry of External Affairs (Southern Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of his return to India.
