**ORDER**

**Subject: Deputation of Dr. Gopal Krishan, Scientist 'E', National Institute of Hydrology, Roorkee to attend a Training Course on "Water Isotope Analysis by Laser Spectroscopy, EVT2303868" at IAEA, Vienna, Austria from 7th to 11th October 2024 (excluding travel time)**

Sanction of the Competent Authority is hereby accorded for deputation of Dr. Gopal Krishan, Scientist 'E', National Institute of Hydrology, Roorkee to attend a training Course on "Water Isotope Analysis by Laser Spectroscopy, EVT2303868" at IAEA, Vienna, Austria from 7th to 11th October 2024 (excluding travel time).

2. The expenses for the participation of Dr Gopal Krishan, Scientist-E in the above-said training course is fully funded by IAEA, Vienna. This funding, amounting to approximately Euro 2,481.36 covers all travel expenses to and from Vienna, Austria, as well as living and incidental expenses during the meeting. The proposed visit incurs no financial liability either on the part of the Ministry of Jal Shakti, DoWR, RD&GR or NIH.

3. The period of absence from the post in India and grant of pay and allowances and counting of services for the increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned period without prior sanction of the Government of India.

5. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

6. The nominated officer would have to proceed on leave if the invitation from the organizer has been received directly by him by his name by virtue of his expertise in particular field treating such visit in personal capacity.

7. The officer shall submit a report about their visit to the Ministry of External Affairs (Central Europe Division) and Department of Water Resources, RD&GR (EA & IC Section) within one month of their return to India.
